Meeting was called to order at 11:05.

Cubelet Presentation – Ms. Steele and 2nd Grade students

Mrs. Rogers: I'd like to say thank you to the PTO for purchasing the Cubelets.

Mrs. Steele and I first saw cubelets at the regional and NJ science conventions. What we liked about the cubelets was that they could be used from Pre-K all the way to middle school. The cubelets are robotic blocks and depending on the color it changes what the rest of the blocks do. Blocks come with motors, wheels, spinners, motion sensors, heat sensors, lego adapters, bar graphs, etc.

Students from both the primary and elementary school came to the meeting and shared what they built with the cubelets and how they controlled it.

Mrs. Steele: As I tell my students, whatever you build has to have a battery and a sensor in order to make action. The cubelets get the students thinking and they have opportunities to create lots of different actions. Thank you, thank you to the PTO for funding this purchase.

In their classrooms, they have 5-10 minutes of teacher talk and then the students have opportunities to explore, experiment, and create. This innovative style comes with constructive noise and these teachers support and accept this type of learning. Thank you!

On June 8th, you were sent a link to our comprehensive Colts Neck Schools Initiative. The link provides the plans for what's NEXT (the projects and the

designs) in a comprehensive and simplistic way. There is an email address on the website that you can contact if you have any specific questions. There is a video that shows the why and the vision. What's most important is the vote on Oct 2nd. We really want to get the word out. High school students who are 18 are able to register to vote. College students can do away ballots. We need parents help to spread the word to vote. There will be strong communication at Back to School nights encouraging parents to vote. For parents interested in learning more about the initiative, there are opportunities to sign up for tours (2 at Cedar and 2 at Elementary).

The vote is going to be divided into 2 questions so it's not all or nothing. The majority of the projects included in question 1 are eligible for state aid. The auditorium, which will be in question 2, is not eligible for state aid. Included are estimates for the tax impact, but it will be less due to state funding. At this point, the state has not eliminated debt service aid, which is why we would like to move forward sooner than later.

It's been another fantastic year, filled with assemblies, field trips, etc. Thank you for your time and effort in support of the classroom. Thank you for everything you do every single day! Have a great summer!
